## SPEAKERS' BRIEF PROFILES

- **Mr. Ch'ng Soon Heng** – Mr. Ch'ng led and provided assistance to investigators who dealt with offences investigated under the MACC Act 2009 and Penal Code. His duties include planning, supervising and presenting of facts of case to State Director and the Deputy Public Prosecutor. Mr. Ch'ng actively involved with the Prevention Unit in giving lectures, seminars and educational programs. He acts as a resource person assisting MACA in giving lectures to new cadets of MACC regarding the MACC Act 2009. In addition, he gave lectures and sharing of knowledge sessions to anti-graft busters from other countries such as Bhutan, Pakistan, Palestine, Nepal, and Fiji.
- **Y. Bhg. Datuk Hj. Shamsuddin bin Bardan** – MEF Executive Director heads the MEF Secretariat which recommends policies to be pursued by MEF in ensuring that the private sector in Malaysia operates in business-friendly environment so as to ensure the private sector employers remain competitive. Policies to be pursued by MEF are formulated by the Secretariat and after approval by the Council will be submitted to various authorities to ensure that the policies of the Government would not inhibit the vibrancy of the private sector employers. He was the Secretary-General of Confederation of Asia Pacific Employers (CAPE) and Secretary-General of ASEAN Confederation of Employers (ACE) (2013 – 2015).
