MEF Collective Agreements And Awards On Terms And Conditions Of Employment 2023

The Collective Agreements and Awards on Terms and Conditions of Employment 2023 marks the 19th edition of the Collective Agreements and Awards on Terms & Conditions (T&C) of employment published annually by MEF. This milestone edition compiles the terms of employment from 274 collective agreements (CAs) given cognisance by the Industrial Court in 2023, spanning across 42 Unions, 36 economic sectors, and nine (9) Industrial Court Awards that disputed on terms and conditions of employment. It is divided into two (2) major sections, where articles contained in the CAs are compiled into 4 Chapters on Salary and Bonuses, Terms of Employment, Allowances and Benefits, and Leave Entitlement. Another section summarises the Awards on terms and conditions of employment decided by the Industrial Court in 2023.
