


The **Analysis of Collective Agreements (CAs) & Awards on Terms and Conditions of Employment, 2006** is the 2nd publication by MEF analysing salaries and terms of employment from a total of 377 Collective Agreements (CAs) in 37 economic sectors signed in 2006 and from 21 Awards on Terms and Conditions of employment handed down by the Industrial Court in 2006.

The Report were divided into two main sections, namely **Analysis of Collective Agreements** covering 377 CAs which were concluded in 2006 with 46 National Unions and 51 In-House Union analysed the terms of employment, salary adjustment, annual increment and fringe benefits by Union, Industry and Location. The second part of the Report was Awards on Terms and Conditions of Employment, 2006 analysed 21 Awards on Terms and Conditions of employment handed down by the Industrial Court in 2006.

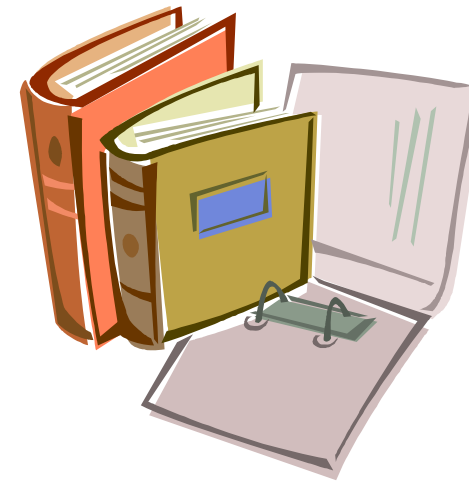
