### INTRODUCTION & OBJECTIVES

The Amendments to the existing Occupational Safety and Health Act 1994 (OSHA 1994) namely as Occupational Safety and Health (Amendment) 2022 were passed on 27<sup>th</sup> October 2021 by the Malaysian parliament and were gazetted on 16<sup>th</sup> March 2022. They extend the scope of applicability to all places of work in Malaysia, including public services and authorities. Employers will have to take a pragmatic approach and ensure a safe working environment for employees who work on site or from home. This includes considering on the “Self-Regulatory” approach by adopting OSH Management System (OSHMS) in their organization as the enforcement of OSH (Amendment) Act 2022 shall take place anytime soon.

The objectives of the seminar are:

- Understand OSH (Amendment) Act 2022.
- Plan for Self-Regulatory compliance in line with OSHMP 2025 perspective.
- Understand the implementation of OSH Management System (OSH-MS)
- Know how to manage OSH risk and coordinate OSH program and design OSH Risk Assessment in accordance to ISO 45001:2018 perspective.

By attending the seminar, participants will be more equipped to implement OSH Management System effectively, in line with Self-Regulatory approach and in compliance with the OSH (Amendment) Act 2022.
