## INTRODUCTION

According to Section 29A (1) of the Occupational Safety and Health Act 1994, any workplace in Malaysia that employs five or more employees shall appoint one Occupational Safety and Health (OSH) Coordinator.

Section 29(4) stipulates that failure to appoint an OSH Coordinator will result in penalties not exceeding RM50,000 or imprisonment not exceeding six months.

His pursuit of technical expertise took him to Waikourou Military Base, New Zealand, where he trained in Basic Radio Engineering in 1966—a skill that later enhanced his ability to communicate critical safety protocols effectively. In 1986, Captain Wan contributed to the International Labour Organization (ILO) in Bangkok, where he helped develop a Construction Safety Training Module. His expertise led to an invitation to Geneva in 1991, where he helped shape the ILO Code of Practice for the Construction Industry.
